Meeting called to order by Mayor Gunter at 4:30 p.m.

INVOCATION/MOMENT OF SILENCE – Councilmember Sheppard

PLEDGE OF ALLEGIANCE – Councilmember Sheppard

Roll Call: Mayor Gunter, Councilmembers Carr, Cosden, Hayden, Long, Sheppard, Steinke, and Welsh were present.

CHANGES TO AGENDA/ADOPTION OF AGENDA

Mayor Gunter asked if anyone had any changes to the Agenda. There were none.

Councilmember Hayden moved, seconded by Councilmember Steinke, to adopt the agenda, as presented.

Council polled as follows: Cosden, Gunter, Hayden, Long, Sheppard, Steinke, Welsh, and Carr voted "aye." Eight "ayes." Motion carried 8-0.

RECOGNITIONS/ACHIEVEMENTS

National Vietnam War Veterans Day Observance 2024

<u>Mayor Gunter</u> recognized the Vietnam War Veterans Recognition Act which designates March 29 of each year as National Vietnam War Veterans Day. The City of Cape Coral observed this holiday at the Council meeting preceding March 29. A video was displayed commemorating our nation's Vietnam War Veterans.

Presentation to City Employees for Years of Service By Mayor Gunter

<u>Mayor Gunter</u> recognized an employee for outstanding service and dedication to our City. He thanked that individual for being such a valuable member of our team. The employee had 21 years of service.

Community Recognition Award: Cape Coral BMX Association

City Manager Ilczyszyn recognized the Cape Coral BMX Association who volunteered their time and donated \$10,000 to completely redo the Cape Coral BMX track. January's significant rain event washed away all of the work that was done before the final protective top layer was installed, and the volunteers pressed forward to completely re-do the work.

Pillar of the Community Award - Brought Forward by Mayor Gunter

<u>Mayor Gunter</u> recognized two individuals from our Cape Coral volunteers with earning the distinct title of volunteer with the most hours for 2023. Thomas Lapointe volunteered 1,429 hours in the Patrol and Marine Division, and Joseph Davis volunteered 157.75 hours in the Fire Department's Community Services Program.

APPROVAL OF MINUTES

Regular Meeting - March 6, 2024

Councilmember Hayden moved, seconded by Councilmember Long, to approve the minutes for the March 6, 2024, Regular Meeting, as presented. Voice Poll: All "ayes." Motion carried.

CITIZENS INPUT TIME

Sally Flash voiced her opposition to changes at Jaycee Park including the removal of trees that are not Australian Pines.

Laurie Lehmann followed up on a request for installation of fire barriers at Coviello Park. She inquired when the current sewer systems would be maintained due to local flooding and opposed changes to Jaycee Park.

Tara Jenner announced a guest speaker today at 6:30 p.m. at the Lee GOP Headquarters on US 41. The topic will be sex trafficking as a survivor. She encouraged City Council and anyone running for political office to complete the "We the People" employment application.

Richard Leon represented the Cape Coral Republican Club and explained that on January 30th, the Board passed a Resolution in opposition of the stipend approval.

Kenneth Gavin voiced concern about reoccurring traffic accidents in his neighborhood on El Dorado Boulevard South at the intersection with SW 4th Street. He requested a fourway stop, traffic signal, or any other traffic control.

Lou Navarra thanked Council for recognizing Veterans. He voiced concerns with observance of patriotic holidays; request to increase Citizens Input to five minutes; stipend; denying petitions to City Council; and inquired about overhead projector use.

Bob Lauson voiced opposition to the Yacht Club designs; followed up on questions for the cost of new designs; new building not inspired by the prior building; and architectural model and progress.

Resident inquired why the local news was not present anymore at meetings. He mentioned that people were struggling to survive and moving out of Cape Coral. He voiced opposition to City Council Rules of Procedures.

Albert Nunov voiced opposition to changes to Jaycee Park and letting the park be a place of serenity.

Jay Higgins requested copies of the studies completed by a speaker a few meetings ago on the water situation in the North Cape. He suggested a 12-month moratorium on well drilling and home building in the North Cape until the aquifer can support it. He supported self-storage and car washes with location monitoring. He had concerns about the Yacht Club cost. He opposed picking and choosing not for profits.

Kathleen Lopez voiced opposition to commercialization at Jaycee Park and all City parks.

Resident followed up on her request for voter inquiry. She questioned the legal definition of stipend. She requested background information on the City Attorney. She asked City Council why any of them should be reelected.

Wayne Zom, Southwest Waste Services, shared information regarding the overflowing dumpster in Northwest Cape and shared the remediation efforts.

Resident thanked Council for the Vietnam Veterans recognition. He voiced opposition to changes to Jaycee Park and the stipend.

Tom Cord voiced opposition to Jaycee Park changes as designs did not fit. He suggested Council take a vote about stopping development today.

<u>Councilmember Steinke</u> commented that Kimley-Horn was in the process of creating the architectural model of the Yacht Club building. He shared the ability of the media to watch meetings remotely.

<u>Councilmember Welsh</u> commented on the aquifer levels in the North Cape. City Council has been updated weekly by the Utilities Director who is monitoring the reports.

Councilmember Cosden commented about the fire prevention issue in Coviello Park.

City Manager IIczyszyn responded the work was completed and that the speaker was not satisfied with results. Fire break has been installed and vegetation removed.

Councilmember Cosden commented about the traffic intersection concern at El Dorado.

City Manager IIczyszyn responded Staff would get with the speaker and obtain the details.

<u>Councilmember Cosden</u> responded to the inquiry about the City Attorney's background, noting that information could be obtained from the Clerk's Office.

Mayor Gunter inquired if the fire break was installed by a State Agency.

Fire Chief Lamb responded that they worked with the Florida Forest Service; a grant was received for part of this. We established a protocol with the Parks Department to cut out the understory, the greatest fire risk in that area. The work has been done, and the area is fire safe. Not all vegetation was removed since it is part of an eco-park.

The Resolution authorizes the issuance by the City of not exceeding \$19,800,000 in aggregate principal amount of City of Cape Coral, Florida General Obligation Bonds, Series 2024, in order to finance the acquisition, construction and equipping of various capital improvements authorized pursuant to the November 2018 Bond Referendum Election, pledging the proceeds of ad valorem taxes levied without limit on all taxable property within the City to secure the payment of the principal of, redemption premium, if any, and interest on such bonds, provides for the rights of the holders of such bonds; makes certain other covenants and agreements in connection with such bonds, authorizes a negotiated sale of said bonds to the underwriter described herein, delegates certain authority to the City Manager and the Financial Services Director for the authorization, execution and delivery of a bond purchase agreement with respect thereto and the approval of the terms and details of such bonds, establishes a book-entry registration system for such bonds, appoints the paying agent and registrar for said

bonds, authorizes the distribution of a preliminary official statement and the execution and delivery of an official statement with respect to such bonds, authorizes the execution and delivery of a continuing disclosure certificate and appointing a dissemination agent in connection therewith. (Brought forward by City Management)

City Clerk Bruns read the title of the Resolution.

Financial Services Director Mason explained the following displayed slides:

Public Hearing opened.

Tom Shadrach expressed concern about the GO Bond process; advertisement to the public to get the bond approved; including \$11M for the enhancement at the Yacht Club. He requested the \$19.8M be reduced by \$11M for work not completed. Parks were supposed to be completed by 2021; reduce other costs to pay for that \$40M.

Jay Higgins noted he voted no for the GO Bond. He agreed that the \$11M for the Yacht Club was a selling point. He opined that the building would cost \$20M, if not more, and questioned its funding. There are new parks in the North Cape that will have an amphitheater and questioned why have one at Jaycee Park when the residents oppose.

Peter Nicholsen expressed if it is not broken, then do not fix it, relative to Jaycee Park; he inquired when will there be a full discussion on Jaycee Park.

Public Hearing closed.
