

"PROCUREMENT ORDINANCE" – CODE OF ORDINANCES CHAPTER 2, ADMINISTRATION, ARTICLE VII, PURCHASE AND SALE OF REAL AND PERSONAL PROPERTY



BACKGROUND

The City of Cape Coral Code of Ordinances - Chapter 2: Administration; <u>Article VII: purchase</u> and sale of real and personal property ("Procurement Ordinance") is periodically reviewed to:

- 1. Provide for changes (additions) to streamline procurement process.
- 2. Update or clarify language within the sections



Review of Procurement Ordinance Revisions

In reference to Article VII: Purchase and Sale of Real and Personal Property (Procurement Ordinance), following are the proposed changes:

- Section 2-144 Procurement Procedures
 - a) Change in competitive solicitation dollar threshold to \$250,000
 - Remove Sub section (2) an alternative to the SAC procedure Direct Procurement Authority
 V. Added Language of a Monthly notification to Council of impending or ongoing competitive solicitation.
 - c) Housekeeping items combining sub sections or clarifying language
- II. Section 2-151 Standards of conduct for city officials and employees
 - a) Housekeeping items clarifying language
- III. Section 2-154 Sale of Surplus tangible personal property
 - a) Donation requesting up to \$5,000 dollar threshold to approve administratively
 - b) New section Scrap
- IV. Section 2-155 Sale of Surplus Real Property New sub section (g)
 - Addresses offers delivered to the City to purchase real property
