A RESOLUTION OF THE CITY OF CAPE CORAL, FLORIDA, AWARDING A BID FOR THE PURCHASE OF AMMUNITION TO FLORIDA BULLET, INC., 1ST ROUND AMMUNITION, LLC, LAWMEN'S AND SHOOTERS SUPPLY, INC. MIKE'S WHOLESALE INCORPORATED, SSD INTERNATIONAL LLC, AND DANA SAFETY SUPPLY, INC.; AUTHORIZES THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE THE PURCHASE ORDERS AND FUTURE RENEWAL; PROVIDING AN EFFECTIVE DATE.

WHEREAS, August 16, 2023, INVITATION TO BID #BPD23109MR was issued for the purchase and delivery of ammunition for the Police Department; and

WHEREAS, having received seven bids, the City Manager recommends the award of the bid to Florida Bullet, Inc., 1st Round Ammunition, LLC, Lawmen's and Shooters Supply, Inc., Mike's Wholesale Incorporated, SSD International LLC and Dana Safety Supply, Inc., as the lowest responsible and responsive bidders meeting the requirements and criteria set forth in the invitation to bid, at an estimated annual amount of \$150,000; and

WHEREAS, the terms of the contracts are effective for one (1) year beginning October 1, 2023, with one additional one-year renewal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council hereby awards the bid #BPD23109MR for the purchase and delivery of ammunition for the Police Department to Florida Bullet, Inc., 1st Round Ammunition, LLC, Lawmen's and Shooters Supply, Inc., Mike's Wholesale Incorporated, SSD International LLC and Dana Safety Supply, Inc., in the estimated annual amount of \$150,000.

Section 2. The City Council hereby authorizes the City Manager or his designee to execute the purchase orders and future renewal.
