## CRA RESOLUTION 12 - 24

A RESOLUTION OF THE CAPE CORAL COMMUNITY REDEVELOPMENT AGENCY, AMENDING RESOLUTION 5-23, WHICH AMENDED RESOLUTION 3-23, WHICH ESTABLISHED THE BUDGET FOR FISCAL YEAR 2024; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Cape Coral Community Redevelopment Agency (the "CRA") adopted Resolution 3-23 on May 2, 2023, which established the budget for the CRA's Fiscal Year beginning October 1, 2023 and ending September 30, 2024; and

WHEREAS, Executive Director has established the requirement to amend its Operating Budget for Fiscal Year 2024, and requests that the CRA Commissioners amend the Operating Budget for Fiscal Year 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE CAPE CORAL COMMUNITY REDEVELOPMENT AGENCY BOARD OF COMMISSIONERS:

SECTION 1. Resolution 5-23, which amended Resolution 3-23, which established the budget for the CRA's Fiscal Year beginning October 1, 2023 and ending September 30, 2024, is hereby amended for the Cape Coral Community Redevelopment Agency to hereby adopt, confirm and approve the amended budget, as detailed in Attachment A and summarized in Attachment B, both of which are attached hereto and incorporated herein, as the budget for the CRA for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024 for submittal to City Council.

SECTION 2. This resolution shall take effect immediately upon its adoption by the governing board of the CRA.
