

RESOLUTION 380 - 24

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, CERTIFYING THE RESULTS OF THE GENERAL ELECTION OF THE CITY OF CAPE CORAL, FLORIDA, HELD ON NOVEMBER 5, 2024; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Charter of the City of Cape Coral, Florida, requires the election of the Mayor and Councilmembers; and

WHEREAS, by adoption of Resolution 293-24, the City Council directed that an election for Councilmember in Districts 2, 3, 4, 5, and 7 be held on November 5, 2024; and

WHEREAS, the Councilmembers in Districts 2, 3, 5, and 7 are elected for a four-year term expiring in November, 2028; and

WHEREAS, the Councilmember in District 4 is elected for a two-year term to fill the remainder of the existing term, expiring in November, 2026; and

WHEREAS, the election was held on November 5, 2024, and the votes of the election were canvassed by the appropriate election officials.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, AS FOLLOWS:

Section 1. The results of the general election held on November 5, 2024, are hereby certified as follows:

Section 2. That as a result of the votes cast in the November 5, 2024, election:

LAURIE LEHMANN has been elected Councilmember, District 2, to serve a four-year term expiring November, 2028; and

DERRICK DONNELL has been elected Councilmember, District 3, to serve a four-year term expiring November, 2028; and

JENNIFER I. NELSON has been elected Councilmember, District 4, to serve a two-year term to fill the remainder of the existing term, expiring November, 2026; and

JOSEPH KILRAINE has been elected Councilmember, District 5, to serve a four-year term expiring November, 2028; and

RACHEL KADUK has been elected Councilmember, District 7, to serve a four-year term expiring November, 2028.

Section 3. The appropriate election officials canvassed the votes of the Election, and a copy of the Certificate of Election Results is attached hereto as Exhibit A.

Section 4. This Resolution shall take effect immediately upon its adoption.




