This has resulted in Oasis North and Oasis South teachers working longer hours than their middle and high school colleagues in order to cover assigned duties such as car line etc. Teachers want compensation in one form or another. Superintendent Collins tasked Orcutt with developing a viable compensation plan that includes the input from teachers and administrators that will be brought to the Board at a later date.

SUBJECT: Cape Coral Charter School Authority – Transportation to Purchase Security Cameras for Twelve Charter School Buses

BACKGROUND:

The Charter School Transportation department has twenty-two buses serving approximately 1400 students daily. Each bus has a camera system which is used to monitor the safety of its students. The new cameras are now a three camera system that allows more clear coverage of activities within the bus. These recordings help to hold our staff and students accountable for their behavior and safety on the bus. The Charter School has ten buses that currently have the new camera system. In the past two years, four buses were purchased with the camera systems and six buses were upgraded this summer.

The Charter School has twelve buses that are using old security cameras that are either not working at all or providing poor quality recordings that are not effective for our purposes. The Transportation Supervisor has identified a vendor that can upgrade the cameras from a competitively bid contract. The Charter School would like to upgrade the remaining twelve buses to have the same camera systems across the fleet for safety and accountability purposes. Unfortunately, the transportation department does not have enough currently budgeted funds to proceed with this upgrade. Due to the poor conditions of the old camera systems, the Charter School recommends that the upgrade be completed as soon as possible. The camera system includes a three year warranty on all cameras.

RECOMMENDATION:

The Charter School is recommending the purchase and installation of twelve HD camera systems for a total cost of \$32,760. The charter school is allowed to piggyback on the Brevard County Schools ITB 18-B-071-NC for Bus Cameras, Accessories, and Installation. The amount to cover this purchase would need to be utilized from fiscal year 2021 reserves. This would eliminate the need to budget these items in FY22 and provide a needed system now as opposed to waiting 9 months.

In summary, the recommendation is to piggyback and use the pricing provided based on the Brevard County Schools ITB 18-B-071-NC for Bus Cameras, Accessories, and Installation to purchase twelve HD camera systems. The Governing Board will need to approve that \$32,760 be taken from reserves to cover the cost of the project.
