**MINUTES FOR THE MEETING
OF THE CAPE CORAL YOUTH COUNCIL**

Friday, January 24, 2020

Chair Benitez called the meeting to order at 3:02 p.m.

Pledge of Allegiance – Chair Benitez

Roll Call: Chair Benitez, Members Bradish, Cranford, Dougherty, Figueroa, Logan, Roh, Russell, and Ziegler were present. Member German, Vice Chair Gorbanovski, Nguyen, and Orozco were excused. Member Ico arrived at 3:14 p.m.

CHANGES TO AGENDA/ADOPTION OF AGENDA

Chair Benitez suggested moving item 10.B. (Community Outreach Activity and Events) to the next meeting Agenda.

Committee Member Dougherty moved, seconded by Committee Member Logan, to move item 10.B. (Community Outreach Activity and Events to the next meeting Agenda), and to amend and approve the Agenda (for the January 24, 2020 meeting).

Council polled as follows: Cranford, Dougherty, Figueroa, Logan, Roh, Russell, Ziegler, Bradish, and Benitez voted “aye.” All “ayes.” Motion carried 9-0.

APPROVAL OF MINUTES

Meeting Minutes – January 10, 2020

Committee Member Ziegler moved, seconded by Committee Member Russell, to approve the Regular Meeting Minutes from January 10, 2020, as presented. Voice Poll: All “ayes.” Motion carried.

RECOGNITION/ACHIEVEMENTS

**Florida League of Cities Award Presentation to the Youth Council by
Isaac Salver, President of FLC**

Chair Benitez provided background information regarding the Youth Council participation in the Florida League of Cities conference and video competition. She announced that in October, the Youth Council was announced as one of the five winners of the competition.

She welcomed Isaac Salver, President of Florida League of Cities (FLC) as he was present to present the FLC Award to the Youth Council for the 2019 Video Competition.

Mr. Salver introduced himself and provided background information. He mentioned that he was servicing his 21st year as a Councilmember from the Town of Bay Harbor Islands. He discussed the FLC purpose and involvement with the elected officials from the 412 cities across Florida, providing them with the tools, resources, and training to provide a better "Quality of Life" to their residents. Mr. Salver announced the League's new tag line "Local Voices, Making Local Choices." He mentioned that one of the League's local voice was the youth. He requested that the Youth Council Members share the reasons for their involvement in the Youth Council.

Chair Benitez and Members shared their reasons for participating in the Youth Council.

Committee Member Ico arrived at 3:14 p.m.

Mr. Salver congratulated the Youth Council with their submission of the 2019 Video Competition. He pointed out that the Members were progressive and commended them for thinking outside the box. He presented to the Youth Council the trophy and the faux check in the amount of \$250.

Senior Public Information Specialist Buice captured several photographs of Mayor Coviello, Youth Council, Council Liaison Williams, Advisor Mazurkiewicz, Communications Director Mitchinson, FLC President Isaac Salver, Southwest FLC President William Ribble (Estero Mayor), and Rachel Keesling, Southwest Florida League of Cities Executive Director.

Mr. Salver provided information regarding his initiative called the *Reader2Leaders*, recent book publication, and the program's overall goals and mission focused on connecting students to cities through reading and resources. He announced that he had gift bags for each of the Youth Council Members.

Chair Benitez thanked Mr. Salver for attending and presenting the Youth Council with the FLC Award and check presentation. She discussed how the Youth Council could participate and become involved with the initiative *Reader2Leaders*.

Committee Member Ico discussed the mentoring program offered at her school. She suggested spreading the *Reader2Leaders* program with her school and offered to exchange contact information with Mr. Salver.

Committee Member Ziegler thanked Mr. Salver for his presentation and agreed with the collaboration between the Youth Council and the *Reader2Leaders* initiative.

Committee Member Logan discussed that this would be an opportunity for the Youth Council to participate in the *Reader2Leaders* program. He thanked Committee Member Ziegler for producing the video presentation.

Rachel Keesling, Southwest FLC Executive Director, announced that Mr. Salver's published book would be rolled out the beginning of February. The City Clerk would receive a copy of the book along with the tool kit. She provided instructions on how to obtain more information on the FLC website under the *Reader2Leaders* tab. She stated that the Mayor and Council would be furnished with a printed copy of the book that could be shared at the local schools.

ADVISOR PRESENTATIONS

Upcoming Council Report - Advisor Mazurkiewicz

Advisor Mazurkiewicz provided the following City Council report for January 27, 2020:

- Committee of the Whole (COW) Meeting
- Hudson Creek and Zemel Properties – Proposed Land Use Change
- D&D Bait Shop and boat ramps located in Matlacha – Staff presentation to Council

Chair Benitez inquired if Staff could provide a presentation on the Hudson Creek development topic as it would be an issue that may affect the Youth Council in 10 years.

Advisor Mazurkiewicz responded in the affirmative. He recommended to have Department of Community Development (DCD) update the Youth Council on the topic.

Committee Member Ico inquired about the development status.

Advisor Mazurkiewicz responded that the developer was providing a proposal for the usage of the property at the COW meeting this upcoming Monday.

CITIZENS INPUT TIME

No Speakers.

BUSINESS

Tropicana Park Update – Kerry Runyon, Parks and Recreation Director and Keith Locklin, Recreation Superintendent

Chair Benitez stated that this was a continued discussion from prior meetings, and she opened the floor for updates and input from the Members and Advisors.

Parks and Recreation Director Runyon attended today's meeting to provide and discuss the updates for Tropicana Park. She discussed the following:

- City Council approved the revised concept plans on December 2, 2019 for the seven Neighborhood Parks
- Community Parks pending approval by the City Council on March 2, 2020
- Yacht Club Community Park still being worked on and will not be presented yet

- Tropicana Park construction to start November/December 2020 and complete by December 2021 by consultant, AECOM
- Proposed leases and pending negotiations for the kayak/boating and rowing clubs

Committee Member Ziegler inquired about when the designs would be completed.

Director Runyon informed that the designs would be completed around October 2020.

Community Outreach Activity and Events (10.B. moved to the next meeting Agenda)

Bus Stop Movement Continued Discussion

Chair Benitez stated that this was a continued discussion from prior meetings, and she opened the floor for updates and input from the Members and Advisors.

Committee Member Russell reported that she patrolled the benches near her school and found little to no trash near the benches. She observed that on one of the benches located near a resident's lot, there was a basketball pole in the proximity of the bench obstructing access to the bench.

Advisor Mazurkiewicz requested that the location of the bench be provided to City Staff to ensure that a notification be forwarded to the owners to remedy the issue.

Discussion held regarding:

- Code Enforcement process of issues and compliance process
- Bus Stop Pilot Program update and pending surveys
- Conditions of benches in the proximity of improved vs. unimproved properties
- Benches near vacant lots requiring more patrolling and cleanup
- Challenges with the picnic benches and lack of maintenance
- Members provided updates on individual maintenance of the benches
- Conditions of picnic benches vs. bus stop benches
- List of Claimed and Un-Claimed Benches

Advisor Mazurkiewicz discussed that the Youth Council could be provided a copy of the entire list of benches being patrolled and the ones still requiring patrolling.

Discussion held regarding Youth Council's patrolling efforts and data collection.

Advisor Mazurkiewicz announced that he would share Committee Member Ziegler's written report with the stakeholder task group.

Youth Council Media Recognition Program

Chair Benitez mentioned that this was a continued discussion from the last meeting, and she turned the floor over to Communications Director Mitchinson for an update.

Communications Director Mitchinson reported that there were four submissions received through Google Forms. He requested an update from the Youth Council on their individual efforts in announcing the program with their respective schools. He shared that he would be meeting with the Principal of Cape Coral High School next Tuesday.

Committee Members and Chair Benitez provided updates on their efforts in sharing the Youth Council Media Recognition Program with their schools and students.

Communications Director Mitchinson reminded the Youth Council that at the next meeting the first recipient would be selected. He agreed to provide the submitted applications prior to the meeting for the Members' review.

Chair Benitez discussed the announcement and recognition process.

Youth Council Social Event

Chair Benitez stated that this was a continued discussion from prior meetings and pointed out that there was a quote included in the backup material from Gator Mikes. She opened the floor for further discussion.

Communications Director Mitchinson displayed the quote details on the projector.

Chair Benitez shared the quote details including cost, activities, food, and pointed out that laser tag at the Youth Center would be at no charge.

Committee Member Ziegler voiced that this would be a good bonding opportunity.

Council Liaison Williams mentioned that the Youth Council would need to configure how the fees and costs would be paid.

Discussion held regarding total cost and how many Members would participate.

Committee Member Dougherty voiced that she would prefer that the per person fee be paid by the Members directly and not be taken out of the budget.

Council Liaison Williams announced that Mr. Salver offered to donate \$250 toward the event.

Chair Benitez requested that the Communications Director Mitchinson work with Administrative Griglin in sending Mr. Salver a thank you card.

Consensus agreed, without objection, to move forward with the activity.

 - > How the project impacted your youth council.
- 2 Letter of recommendation from the mayor, a member of the council/commission or city manager.

Your nomination will NOT be scored if missing any of the above.

Feel free to include up to five pages of supportive materials (such as photos from the project, newspaper articles and letters of recommendation).

The contest is open only to youth councils sponsored by a city, town or village government that is a member of the Florida League of Cities.

The deadline for entries is Wednesday, March 25, 2020.

Judging will be based entirely on the youth council's submitted entry. The judges' decision is final. All material received becomes the property of the Florida League of Cities, with permission to use it perpetually and universally, in any manner deemed appropriate by the League, with no additional compensation beyond the award money presented to the winner.

Submission

All work must be submitted through an online form available at flcities.com/resources/youth-councils. You will receive confirmation of submission.

Submissions that are emailed or mailed will not be judged.

Announcement of Winners

Winners will be announced in May 2020. Five projects will be selected as winners. Winners will:

- > Be recognized in press announcements and the League's Quality Cities magazine.

Local Students Win Statewide Community Service Contest

Five Municipal Youth Councils recognized for volunteer service projects

TALLAHASSEE – Five municipal youth councils from cities throughout Florida recently won a statewide community service contest.

The 2019 Municipal Youth Council Community Service Contest, sponsored by the Florida League of Cities, showcases community service projects performed by municipal youth councils that successfully address specific needs in their local communities. Comprised of high school students within the city, municipal youth councils are special councils that typically serve as an advisory board to the local government. They are sometimes referred to as youth corps, teen advisory boards or mayor's youth councils.

“Based on what we’ve seen from municipal youth councils throughout Florida, our future lies in good hands,” said Florida League of Cities President and Bartow Mayor Leo E. Longworth. “These students bring energy and innovative ideas to improve our communities. On behalf of elected officials across the state, I congratulate their efforts and look forward to feeling their positive impact for years to come.”

This year’s contest winners and their projects are:

- **City of Boca Raton Community Advisory Panel Youth Subcommittee** – *“LEAD Green”*
- **City of Haines City Youth Advisory Council** – *“Boys & Girls Club Revitalization”*
- **City of Homestead Mayor’s Youth Council** – *“Government Shutdown Relief Project”*
- **City of West Palm Beach Mayor’s Youth Council** – *“Speak Your Mind”*
- **City of West Park Youth Council** – *“Shoebox for the Homeless”*

The **“LEAD Green”** project from the **City of Boca Raton Community Advisory Panel Youth Subcommittee** is a new initiative that empowers and encourages young volunteer groups from different schools throughout the city to collaborate and work together. Their efforts have resulted in several environmental projects across the city including planting trees, rehabilitating nature trails and performing beach cleanups. The goal of **“LEAD”** is to preserve the environment for future generations, make positive contributions to the City of Boca Raton and its communities, and to raise awareness among residents.

The “**Boys & Girls Club Revitalization**” project from the **City of Haines City Youth Advisory Council** was focused on renovating the Dolphus Howard Building, home to the Citrus Center Boys & Girls Club. The youth council worked to clean up and paint both the interior and exterior of the building before adding the final touches on the inside including new games, furniture and electronics for members of the Boys & Girls Club to use.

The “**Government Shutdown Relief Project**” from the **City of Homestead Mayor’s Youth Council** focused on helping those residents of Homestead who were affected by the shutdown of the federal government. Members of the youth council collected donations of food and everyday necessities such as laundry detergent and toiletries. Those items were then dispensed to residents in need.

The “**Speak Your Mind**” project from the **City of West Palm Beach Mayor’s Youth Council** was a town hall event created by students for students. For the event, the council invited a panel of psychologists, therapists, school administrators and the city’s police chief. Students from schools throughout the city were also invited to participate. The goal of the event was to discuss topics such as mental health and school safety and to create an atmosphere in which students could voice their concerns and have their questions answered.

The “**Shoebox for the Homeless**” project from the **City of West Park Youth Council** focused on helping the homeless population within the city. It was created after members of the council noticed an increase in their city’s homeless population. Members filled shoeboxes with toiletries and staple food items, which they then delivered to their city’s police station, which partnered with them for the project. Deputies kept the boxes in their trunks and handed them out to those in need on behalf of the youth council.

Contest winners will receive a trophy, be recognized at the League’s Annual Conference, be featured in the League’s statewide publication, *Quality Cities (QC)* magazine, and have their projects featured on the League’s website and social media accounts.
