CITIZENS INPUT TIME

John Bashaw appeared to thank the Youth Council for keeping the Boardwalk Project in play. He added clarification to his original request to have the Youth Council evaluate the concept of a Boardwalk from Northwest Cape Coral to Charlotte Harbor. It does not necessarily have to originate at Crystal Lake Park and end at the City-owned property. Ideally, it would be an elevated path for Residents to enjoy that phenomenal piece of property. He also clarified that he was not looking to add a tremendous amount of work to the Youth Council's or Staff's schedule but to decide on a conceptual design to be approved by the Youth Council and then the NWNA (Northwest Neighborhood Association) would take over to work with Staff and the Youth Council.

The Love Locks Project – Brought forward by Chair Ziegler

<u>Chair Ziegler</u> stated that this was a project she proposed at the last meeting. She reported that Parks & Recreation Director Runyon requested more information. Originally, the Love Locks idea was to put the Lock on a fence and throw the keys out. Cape Coral is an environmentally friendly City so keys could not be thrown into the waterways. Currently, the Yacht Club does not have a section of fencing for the program, but there are other locations in other parks that could be researched.
