Current Program - Kayak Shack


Location: Four Mile Cove Ecological Park

Hours of Operation: 8:00 a.m. - 4:00 p.m. weekends November through May

Offerings: Kayak Rentals and Guided Paddle Tours (Moonlight and Daytime)

Goals: Explore nature, learn about the ecosystem, and engage in fun, safe activities.

Staffing: Two Contract Center Attendants are staffed at the Kayak Shack. Two full-time Rotary Park staff handle logistics to manage the kayak rental program and lead guided paddle tours.





Expand Services Options

- 1. Offer similar program as Eco Park utilizing in-house staff to operate and manage.
 - a. Requires additional resources to accomplish (staff, equipment, storage)

Kiosk Vending Machine Update

Florida Statue 327.54

Florida Administrative Code 68D-34.002 Livery Pre-Rental and Pre-Ride Instruction Requirements.

(1) Any livery offering vessels for lease or rent must ensure that all individuals who rent or lease a vessel, as well as each potential operator of a rented or leased vessel, have received pre-rental and pre-ride instruction in the following topics prior to operation: (a) Operator responsibility, including ethics, courtesy and good judgment on the water.
