





New Florida House Bill 657

- 1. Took Effect July 1, 2023
- Authorizes local agencies to use Speed Detection Systems (i.e. radars, cameras) to enforce school zone speed limits. Allowed <u>at warranted locations</u> only.
- 3. Penalties
 - For violations in excess of <u>10 mph over school zone speed limit</u> during flashing light time & **posted speed limit** during school hours
 - ✓ \$100 penalty; no points are assessed
 - ✓ \$60 to local government
 - ✓ \$5 to Crossing Guard program
 - \checkmark \$12 to local schools
 - ✓ \$3 to Florida Dept of Law Enforcement (FDLE)
 - ✓ \$20 to the State

SUMMARY ANALYSIS

CS/CS/HB 657 passed the House on April 28, 2023, as amended, and subsequently passed the Senate on April 28, 2023.

The bill authorizes counties and municipalities to use speed detection systems, which are similar to red light cameras, to enforce school zone speed limits for violations in excess of 10 miles per hour over the applicable speed limit when children are going to or from school and during the entirety of the school day. The bill:

- Defines the term "speed detection system" and requires a county or municipality to enact an ordinance
 regarding the placement or installation of speed detection systems and to make a determination that
 the location of such system warrants additional enforcement action.
- Requires signage warning motorists that speed detection systems are in use.
- Requires a public awareness campaign prior to commencing enforcement of school zone speed limits with speed detection systems.
- Requires the governing body of a county or municipality operating one or more school zone speed detection systems to hold public meetings regarding contracts and data reported to the Department of Highway Safety and Motor Vehicles (DHSM).
- Creates a School Crossing Guard Recruitment and Retention Program using proceeds from penalties
 resulting from enforcement of school zone speed limits through a speed detection system.
- Requires speed detection systems to be installed according to specifications established by the Department of Transportation.
- Provides requirements for issuing a notice of violation or, if necessary, a uniform traffic citation.
- Provides for a \$100 penalty for each violation and provides for the distribution of the proceeds to state and local governments.
- · Provides defenses for persons who receive a notice of violation or uniform traffic citation.
- Provides that enforcement using a speed detection system supplements enforcement by a law enforcement officer.
- Provides procedures for hearings regarding these violations.
- Provides requirements for the retention and destruction of data obtained from speed detection systems
- Requires reporting by counties and municipalities that implement speed detection system programs in school zones and requires a summary report by DHSM.
- Exempts speed detection systems from DHSMVs requirements for radar or LiDAR units, while requiring a speed detection system to perform self-tests as to its detection accuracy.
- Prohibits points from being imposed for a violation of unlawful speed in a school zone enforced by a speed detection system and prohibits such violations from being used for purposes of setting motor vehicle insurance rates.

New Florida House Bill 657

4. What will be required of the City?

(Ongoing Coordination - City Attorney's Office/ City Manager/ CCPD/ Public Works)

- Enact an Ordinance to authorize the use of Speed Detection Systems within warranted school zones in the City; to establish a School Zone
 Speed Enforcement Program per HB 657... (City Attorney's Office)
- Collect Traffic Data to determine whether a school zone constitutes a "heightened safety risk" that warrants additional enforcement measures (Public Works)
- Procure a Speed Detection System Vendor (if warranted) to install, monitor, and operate & maintain the Speed Detection Systems
- Assign Staff to review violations and appear in court (CCPD)

CTAC STREET SIGN TIMELINE & FORECAST SHOWING REVISED PLAN APRIL 2024

PAST TIMELINE

9/28/22 – Hurricane Ian

Early 2023 – 2/15/24 (bids opened) – FEMA contract for local road signs written and opened, award tentative May 1, 2024.

4/10/23 – All stop signs completed

Early 2023 – 3/4/24 – FHWA contract for major road signs worked on but then suspended due to the need to increase rate of sign installation. Also, the forecast is that federal reimbursement would be approximately 15% reimbursement for FHWA signs (Lee County, winter 2023-2024)

6/20/23 – City started straightening major road signs since these would not be reimbursed by FHWA. Over 1,600 signs were straightened.

1/29/24 – City Manager directs City sign crews to start replacing signs on major roads


1/30/24 – City sign crews start replacing signs on major roads

2/7/24 – Reported to CTAC that City sign crews started replacing signs on major roads on 1/30/24.

4/9/24 – From 1/30/24 to 4/9/24, City crews restored 1296 signs and posts major roads. This compares to a total of 740 signs and posts last month averaging 25 signs and posts per work day in March through April. Completed streets are Del Prado (city jurisdiction only), Santa Barbara, Cape Coral Pkwy, and NE 24th Ave. Near complete or underway are El Dorado N, Coronado, and Andalusia. Following those will be Country Club and Nelson.

FORECASTED TIMELINE

- City sign crews to continue working on major roads. If their production is not interrupted,* signs on major roads should be complete by 12/31/24. (This was previously forecast as June 2025.)
- 2. June 2024- FEMA contract projected to begin. Hopefully completed by 12/31/24.
- 3. Public Works is currently in the process of identifying city workers who can enter data for the contractor for the FEMA contract as signs are installed **so our own sign crews are not needed for data entry and their production is not interrupted.***
- 4. Public Works is currently refraining from hiring contractors other than those for the FEMA contract (all local roads). (JOC and CMAR contracts or a quote were previously discussed.) It is doubtful that any additional city data collectors (as discussed in #3) would be available beyond those discussed in #3.

RESURFACING BUDGET NEEDS-URGENT UPDATE CTAC APRIL 17, 2024



Resurfacing, Urgent Update

- 1. This is an urgent update since some <u>decisions need to be made</u>.
- 2. The Major Road Resurfacing and Spot Paving bids have opened and costs have increased around 40%.
- 3. The Local Roads bid opens May 7, 2024, and similar high costs are expected.
- 4. This presentation is to explain the several options that could be chosen.
- 5. Guidance from CTAC is being requested so Public Works knows the size of contracts to bring to Council for approval.
- 6. <u>The overall questions pertain to using Gas Tax Reserves and using General</u> <u>Fund Reserves</u>.
- 7. Some of the numbers are estimates. The Finance Department will assist in final calculations to confirm the funding is as estimated to match Council's



Resurfacing, <u>Recent History</u> 2011 - 2023

- Historically, \$6.5 Million was allocated yearly for Local and Major Road Resurfacing, Spot Paving, and Pavement Preservation.
- Lifespans were assumed to be 20-24 years for Local Roads and 10-12 years for Major Roads.





Projections made July 12, 2023

In the CTAC meeting on July 12, 2023, items were noted:

1. New specifications (thicker Major Roads) 2. Past Major Roads cost increases of 330%. 3. Past Local Roads cost increases of 60%. Looking at roads in need of resurfacing and their expected lifecycles, cost needs were projected for future needs. Unfortunately, costs have gone up another 40% in one year. The following figures show the predicted needs as of July 12, 2023,





From 7/12/23: Resurfacing, Pavement Preservation, and Spot Paving Projection FY2024 and beyond – CITY-WIDE

Projected Yearly Cycle Cost with extended lifecycles (15 years for Majors and 25 years for Locals) and omitting UEP North 1 -5 and Festival Park

<u>SPOT PAVING (Variable)</u>	\$500,000
PAVEMENT PRESERVATION (approx. 50 Lane-miles)	\$500,000
LOCAL ROAD RESURFACING (71 Lane-miles)	\$4,800,000
MAJOR ROAD RESURFACING (40 Lane-miles)	\$5,700,000

TOTAL

\$11,500,000



Of the \$11,500,000 requested for Major and Local Roads, Spot Paving, and Pavement Preservation, proposed budgets are currently:

Proposed Budget 2025	\$7,900,000
Proposed Budget 2026	\$8,400,000
Proposed Budget 2027	\$8,900,000
Proposed Budget 2028	\$9,400,000
Proposed Budget 2029	\$9,900,000

<u>It is unknown at this time if Program modifications will raise</u> <u>these amounts.</u> Also, 2024 was not budgeted with any increases, and the 40% inflation this year had a great impact.



Resurfacing Needs- Public Works costs for Spot Paving and Major Road Costs are as "just opened." Local Road costs are "as estimated" based on the Major Roads.

Spot Paving\$969,027Major Roads\$11,224,443Local Roads\$5,391,467* Estimated

TOTAL \$17,584,937

The large difference over the budget was due to a 40% cost increase, and aligning bids to CTAC's interest in "catching up" on lifecycles.



Option 1- Pave every road bid 59 Iane miles (Majors) and 42.3 Iane miles (Locals)







Using Gas Tax Reserves, FY 2024 Available Funds* \$10,500,000 *(FY24 Adopted \$6,900,000 + \$3,600,000 prior year balance) Needed for all but Alt 1, 2 (Majors) & Alt 2 (Locals) \$9,980,390 Therefore no addition funds are needed {surplus} \$519,610

This would have the largest impact on pavement lifecycle slippage and increase of future potholes.




