We will be bringing in a private firm to assist with short-term Building Official services while we go through the process of recruiting, interviewing, and selecting a new Building Official. We have been advertising for the Assistant Building Official for 30 days or so, and that position has been difficult to fill as well. In addition, we are using a separate staffing company that will provide us with some higher-level personnel to assist the Development Services Director. There are several positions to fill in Development Services, and staffing agencies would provide the shortterm staffing.

Mayor Gunter reminded Staff that the next step after the 60 days process would be to identify the push-button permits that can be brought online to move along the process.
