City Manager Ilczyszyn addressed the resident's complaint of street flooding:

- Storm surge was down by 5:30 a.m. on Friday morning
- Rain events, certain intensities, system may be overloaded
- Hurricane lan inundated our entire City with 6 to 8 feet of water and by 7:00 a.m. the following day the entire City had drained
- Hurricane Helene, storm surge came in until 1:30, 5.7 feet of storm surge, by 5:30 the next day all the streets drained
- Streets are meant to drain when they are completely flooded from doorstep to doorstep at a certain rate
- If we have rain events that exceed the amount of drainage that the pipes can handle, you will get isolated flooding which will happen in any city in the nation.
- Storm systems are only designed to handle a certain amount of capacity passively
- We are designed to handle just about every storm that can come our way.

City Manager Ilczyszyn provided takeaways from Hurricane Helene. If expecting 6 feet or more of surge, regardless of the wind, the City should be enacting a Local State of Emergency due to the flood aspect. Our labor contracts do not address how we pay our employees who get deployed out of Public Safety and may have to be considered.

<u>Councilmember Steinke</u> inquired about the assessments of teams to evaluate the southern end. Was anything done at Rosen Park or Horton Park?

Director Lamb explained they went all the way up to the midpoint, east of Del Prado, and south of Cape Coral Parkway. Drive throughs were done through the Northwest and other parts of the City. Resources were focused based on scouting reports.

Lost power in Chambers around 5:00 p.m.

Discussion held regarding levels of surge were as high as they were in lan, was not much room for water to come in based on washout experienced from lan.

<u>Councilmember Sheppard</u> surveyed the City after the storm passed and received much positive feedback from citizens on the City's response and recovery efforts.

Councilmember Carr inquired about the estimated storm surge.

City Manager IIczyszyn explained the expected storm surge was 3 to 5; wind was not over 50, one gust at 58. Decision was not to enact a Local State of Emergency. Now with having the actual high watermarks and the assessments on how close we were to having a totally different picture within a half-foot, if we have a 6 ft. or greater prediction, there would be a strong recommendation to get into a higher level of readiness.

Director Lamb explained the provisions under a Local State of Emergency that are enacted including no sale of alcoholic beverages and double time for employees. He added that there were six City employees that were personally impacted with severe flooding on their properties; they live outside the area, and we were offering them as much assistance as we can.

- Amended Conservation Easement removes a portion of the original easement encumbering the area of sanitary sewer lines and adds another area of equal size.

First Public Hearing opened.

Joe Mazurkiewicz, President, BJM Consulting, on behalf of numerous commercial property owners, voiced concerns with driving the market, frontage on major arterials, additional screening requiring annual inspections, conditional uses, and eliminate footage between properties.

First Public Hearing closed.

<u>Councilmember Welsh</u> announced that these two Ordinances came forward at the meeting of the Planning and Zoning Commission today, and they recommended denial.

<u>Councilmember Carr</u> inquired if the 500-foot minimum was at the property line or to the structure on that property.

Senior Planner Santora displayed the slide relating to it and explained it would be calculated to the property line as it reads in the proposed Ordinance.

Discussion held regarding:

- Minimum frontage along arterials or collectors
- Buffering, six-foot berm, plus landscaping
- Adjacent to canal frontage
- Subsection 5.11.17.D. where a canal or right-of-way separating two property lines
- Buffer is still necessary and must be provided.
- Obstructive views within the 20 feet of a waterway
- Type of canal frontage, end versus along the canal, marine improvements criteria

City Manager Ilczyszyn inquired about addressing language covering the buffer, whether it is abutting canal right of way in a residential area or real property that is residential.

Councilmember Carr responded in the affirmative.

City Manager Ilczyszyn noted they will make sure language is included to address that.

Councilmember Carr inquired if the moratorium ceases at the time Ordinance is passed.

City Attorney Boksner responded in the affirmative

<u>Councilmember Steinke</u> inquired about the transparency and the current Code for buffers at three feet.

Senior Planner Santora explained there is that requirement for fences. The wall and berm as required by our screening section in our Landscape Code are required to be set at the back of the buffer area. All vegetation and area must be in front of that when buffering in residential uses.

Councilmember Steinke suggested including illustrations at the second and final hearing.

First Public Hearing opened.

Joe Mazurkiewicz, President, BJV Consulting, on behalf of numerous property owners throughout the City, ditto his prior comment. He supported the conditional use. He was concerned about requiring 75% to be on the major roadways. He mentioned a comment from the P&Z meeting this morning that people are going as far as Sarasota for their storage needs.

First Public Hearing closed.

Councilmember Sheppard returned at 5:34 p.m.

<u>Councilmember Welsh</u> commented on exterior or interior storage that this covers, eliminate unsightliness. Rewrite language to allow interior storage for RVs and trailers. Possibly change the sale and rental to just maybe rental.

<u>Councilmember Carr</u> also had the same concern about outside storage due to parking restrictions on properties. He suggested a wall or enclosure to shield it. This type of facility is needed in our City. Some appropriate language is needed for permitting.

<u>Councilmember Steinke</u> suggested finding some way to provide storage opportunities for boat owners. Supply interior store but exterior storage should be visibly pleasing. Consider reevaluating compliance with Section C perimeter landscaping.

Mayor Gunter inquired about the storage facilities renting spaces for vehicles.

Senior Planner Santora explained the prohibitions.

Discussion held regarding the current Code which does not allow parking of boats, trailers, box trucks at storage facilities, only permissible in industrial districts, and only when the site is developed as part of a ring where they have a wall around the site.

Mayor Gunter suggested more information on what would or would not be permissible.

Councilmember Long inquired how the conditional use process works.

Senior Planner Santora explained the process for conditional use section; check buffering requirement, locational requirements, adjacent to residential, working out specific landscaping, part of the process of getting a permit and also for review.

<u>Councilmember Long</u> noted this was an opportunity to look at these on a case-by-case basis on site specific basis.

Senior Planner Santora responded in the affirmative.

Councilmember Welsh agreed with conditional use but avoid excess restrictions.

City Manager Ilczyszyn confirmed that we will develop some diagrams and illustrations and some examples of enclosed outdoor RV in both storages to show at one-on-ones.

Mayor Gunter asked if this could be discussed at a COW.

City Attorney Boksner pointed out that if the item goes back to a Committee of the Whole, it would be forced to start the process for the public hearings. The first reading could be October 30th, and the second reading would not be until after the new Council is appointed.

<u>Councilmember Welsh</u> inquired if the modification was based on the two changes, would it still be able to move forward at the second reading and not hold up the process?

City Attorney Boksner responded in the affirmative.

Mayor Gunter explained the reasons for bringing this back to a Committee of the Whole.

<u>Councilmember Hayden</u> thought the course of action was to protect major corridors and preserve the commercial premium parcels.

City Manager Ilczyszyn summarized:

- One Councilmember would like to allow a rental business out of a storage facility
- Two Councilmembers would like to allow outdoor storage inside a wrapped facility
- Two Councilmembers concerned about buffering at the end of a canal whether vegetative or fence

- If it is the will of Council to allow rentals out of storage units or to add a totally different type of related storage facility, it could be addressed as a whole section.
- We could still do this and then decide what to do with other type of storage, presumably RV and boat storage, not mini storage or just open
- Did not see Council as a whole had any issues
- If there are four Councilmembers that want to address all three of these things, the right thing to do would be to suspend this process now and go back to a COW
- He heard individual comments, not as a collective body
- Issues could be addressed with individual Councilmembers that brought those up

<u>Councilmember Long</u> inquired if all these could be allowed under the conditional use request.

Senior Planner Santora explained the process and needing to be spelled out in the conditional use.

<u>Councilmember Steinke</u> clarified he did not advocate for the units to be used for the purpose of running a rental business. The entire facility may want to have ability to rent a truck or trailer for the purpose of moving items. He would not be in favor of running a rental business out of a rental unit.

<u>Councilmember Sheppard</u> would like to learn more about this topic. He was under the impression that the storage facilities would allow commercial trailers, vehicles, and boats.

<u>Councilmember Welsh</u> was in favor of allowing commercial vehicles to park by storage units, trying to keep local businesses here instead of driving over the bridge. He agreed if the storage facility offers the rental truck, it would be acceptable, not have a business operate out of a rental unit.

Mayor Gunter summarized:

- Rental of trucks provided by facility, service by principal tenant similar to selling boxes or a lock, ancillary service.
- On site parking of vehicles, trailers, RVS in the interior of a structure
- Buffering by the building so it is not visible

City Manager Ilczyszyn clarified:

- Rental business service offered by the principal business being offered to tenant
- Within the Code, the principal business of the storage unit will have the ability to rent a vehicle for the purpose of transporting goods
- Others such as allowing Penske to use the parking as commercial or U-Haul to rent their commercial parking different

Mayor Gunter asked him if further direction was needed from Council collectively.

City Manager Ilczyszyn understood that it was an ancillary service of the principal business.

<u>Mayor Gunter</u> asked about the parking of vehicles, trailers, box trucks, etc. on the inner perimeter of a building that is not visible from the roadway.

Senior Planner Santora noted a subsection could be written that addresses it specifically to allow for that. Parameters would have to be worked out.

City Manager IIc:zyszyn noted there was a good example of that recently built off Diplomat and one is on Pondella.

Mayor Gunter questioned the buffering on the canal side.

Senio: Planner Santora explained it was for car washes and did not know if this condition would still apply.

Mayor Gunter asked for feedback from Council to address those two items.

<u>Councilmember Steinke</u> asked for clarification: buffering and the flat deck storage.

Mayor Gunter clarified it was the rental of trucks and the parking of vehicles.

Councilmember Steinke noted the need to see more illustrations.

<u>Mayor Gunter</u> summarized to have these items fine tuned and implement some of them in the Ordinance for the second hearing in two weeks.

City Attorney Boksner explained many of these are prohibited in the existing draft but may be conducted by way of the review of the conditional use. (There was no objection.) He explained if he removed the outright prohibition and make it as a part of the analysis to the conditional use approval for the site-specific application, it appears that this would address the majority of the concerns.
