District 5 Temporary Appointment Interviews

City Clerk van Deutekom announced the following candidates that applied for the District 5 seat:

Scott Michael Branan - present Danne Carmen Puleio - present James David Schneider - present

Each applicant discussed their qualifications and their concerns with City of Cape Coral processes and procedures.

<u>Councilmember Leon</u> inquired of each applicant if they had reviewed the Charter, Council meetings, Budget, and knowledge of the Sunshine Laws.

Councilmember Burch inquired with Mr. Puleio about his position on the topic of the 4 a.m. bar hours. Mr. Puleio responded that he was in favor of the 4 a.m. bar hours.

<u>Councilmember Burch</u> inquired with Mr. Puleio about his position on the Golf Course property. Mr. Puleio responded that he leans towards allowing it to be developed, but he would like more background on that topic.

Councilmember Burch inquired with Mr. Branan about his position on the topic of the 4 a.m. bar hours. Mr. Branan responded that he was against the 4 a.m. bar hours.

<u>Councilmember Burch</u> inquired what was Mr. Branan's stand on the Golf Course property. Mr. Branan stated he was in favor of a park versus a home site development.

Mr. Schneider stated he was initially not in favor of the 4 a.m. bar hours but changed his opinion and was in favor. He stated that regarding the golf course property, he rejected the application for change of the LUDR's as part of the Planning & Zoning Commission.
